with obligation to play FOURTH HORN and following positions.

(Retribution: level 4 + 2.78%, artistic area)

1. The auditions are open to European Union citizens of either sex (D.Lgs. 196/2000), eighteen or older on the deadline date for application submission, and who possess a diploma in the required instrument, issued by a Music Conservatory or equivalent Music Institute in Italy or abroad.

Non-European Union citizens will also be admitted to the auditions, provided they already possess a valid residence permit allowing immediate employment with the Theater.

2. Participants must not have any criminal convictions, except for negligent offenses, and must have an adequate knowledge of the Italian language. The auditions will take place at the Teatro del Maggio Musicale Fiorentino, Piazzale Vittorio Gui, 1 - Florence, on Monday, September 23, 2024, with all candidates summoned at 9:00 AM, if needed the audition it might continue the following day. No notice of summons will be sent: each candidate must therefore show up at the Theater on the specified day and time and present a valid identity document, under penalty of exclusion.

The EXAMINING COMMISSION, composed of experts, will be appointed by the General Manager of the Theater and may require candidates, at its sole discretion, to perform the entire examination program (see below), or only part of it.

The RESULTS of the exams (preliminary rounds/ final round - numerical score) will be posted in the Theater's notice board; MINIMUM PASSING SCORE is 8.50 out of 10.00.

ALL APPLICATIONS WILL RECEIVE A RESPONSE confirming the reception of the application. The Theater is not responsible for any transmission issues.

In the application (see sample form), the candidate must indicate: name and surname, place and date of birth, citizenship, and address of residence (including phone numbers, mobile, fax, and email), possession of the required educational qualifications; the application must be signed and the following attached: permit/residence card, for non EU Citizens, and a Curriculum Vitae.

Submitting the application implies unconditional acceptance of the final, non-negotiable judgment of the Examining Commission. Incomplete applications (including missing required attachments) or not using the forms provided by the Theater will not be accepted.

By participating in the selection process, the candidate acknowledges that passing it does not guarantee the right to permanent employment, but only the possibility of being included in a ranking through which the Theater may offer fixed-term employment contracts.

The final ranking resulting from this procedure will be valid and effective from September 25, 2024, until September 24, 2025.

The candidate also acknowledges that participation in this selection process fully exhausts any previous rankings and acquired rights from previous selection procedures, while the service rendered, for the sole purpose of maturing the right of precedence as regulated by the relevant laws, will still be considered.

Personal Data collected by the Theater during the selection procedure will be processed in accordance to the Legislative Decree 196/2003 and GDPR 2016/679.
